## ATTENDANCE POLICIES

**Eligible to Attend:** BONA FIDE WHOLESALERS, as defined by the NAWLA Bylaws, Foreign Wholesalers and Agents (who primarily **buy**) and Importers are invited to attend as non-exhibiting registrants. EXHIBITING MANUFACTURERS, EXHIBITING WHOLESALERS, EXHIBITING SERVICE PROVIDERS and NORTH AMERICAN BASED EXHIBITING IMPORTERS OF OFFSHORE PRODUCTS **are also eligible to attend.** **All attendees, including booth personnel, are required to submit individual registration forms. No registrations are included with the booth fees!** **A minimum of one exhibit booth personnel per booth MUST be registered and paid in full no later than August 11, 2008.**

**Not Eligible to Attend:** Primary manufacturers, service providers, and North American based importers of offshore products (who primarily sell) who are **not exhibitors**, and retailers, buying cooperatives, builder/contractors and others who do not clearly satisfy the NAWLA Bylaws definition as wholesalers **are not eligible to attend.**

**Badge Policy:** **Badges must be worn for admittance to all NAWLA functions.** Registrations based on bogus company affiliations and badge switching are embarrassing for all concerned, **are absolutely prohibited**, and could lead to expulsion from the NAWLA Traders Market® and forfeiture of registration fees. **No alterations to badges or business cards are allowed.** Only registrants possessing valid credentials will be permitted entrance to the Market floor or to any other NAWLA Traders Market® function. In order to preserve the integrity of this event, registration requirements as determined by NAWLA will be strictly enforced.
